2019 BUDGET NEWS

Council has approved the 2019 expenditures at \$2.764 million of which \$2.39 million are operational costs and \$373,940 are capital. The following is a breakdown of operating costs: Roads 36%; Administration 19%; OPP 15%; Fire 9% and Environmental (Waste Site) 8%. All other departments make up the remaining 13% (Library, Community Centre, Building, By-law and Animal Control; CRCA, Recreation, Cemetery, Heritage and Planning).

Our Capital Budget will cover a number of road improvements as well as funding for the Recreation Park and Fire Services. In order to meet all of our obligations, 2019 will see a modest municipal tax rate increase of 2.74%. With an average residential property in the Township assessed at \$240,400 the overall increase will be about \$9.91 for that property. However, the tax increase will vary for each property based on the property assessment by MPAC.
