

**A BY-LAW TO ESTABLISH FEES AND CHARGES FOR SERVICES PROVIDED BY THE
CORPORATION OF THE TOWNSHIP OF FRONT OF YONGE**

WHEREAS Section 391, Municipal Act, 2001, S.O. 2001, as amended, authorizes a municipality and a local board to pass by-laws imposing fees or charges for services or activities provided or done by or on behalf of it and for various types of licences, permits and approvals;

AND WHEREAS Section 69 of the Planning Act, R.S.O. 1990, c.P.13, as amended provides that the Council of a municipality by by-law may establish a tariff of fees for the processing of applications made in respect of planning matters;

AND WHEREAS Section 7 (1) of the Building Code Act, S.O. 1992, Chapter 23 as amended, provides that a Council of a municipality pay pass by-laws requiring the payment of fees on applications on the issuance of permits, requiring the payment of fees for maintenance inspections, and prescribing the amount of the fees.

NOW THEREFORE the Council of the Corporation of the Township of Front of Yonge enacts as follows:

1. The Corporation of the Township of Front of Yonge hereby adopts the consolidated list of fees, attached hereto as Schedule "A", and forming part of this by-law.
2. This by-law shall come into full force and effect on the date of passing and shall be cited as the "Consolidated Fee By-law".
3. This by-law repeals and replaces By-law #12-25.

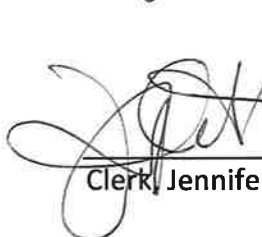

Notes: If Special Meetings of the Municipal Council are deemed advisable for a planning matter, such costs shall be borne by the applicant and shall be in addition to the costs referred to above. Fees prescribed above shall be payable upon formal application to Council. Agreement of Indemnity to be signed by all applicants. Should a third party appeal to the O.M.B., a deposit of \$1000.00 is to be made by the applicant. The fees set forth in the by-law are minimum fees only and where the municipality requires the professional services of a planner, solicitor, engineer or surveyor, etc., in connection with an application in the opinion of the Municipality, the costs charged to the Municipality by such professional, shall be payable by the applicant. For example: Costs of attendance at a Council meeting by the Municipal Solicitor or Planner. The Corporation of the Township of Front of Yonge may at its discretion refund to the applicant, any or all of the prescribed fees as set out in this by-law, if it is deemed advisable and fair to do so.
